

PLAINTIFF'S WEAPONS FOR THIS THEATER IN "THE WAR OF WORDS"

*Free Exercise Clause in the Right to Petition the Government as Ones Shield...
with the Plaintiff's Free Exercise Right to Protest as Ones Sword*

"Throughout the world, masks are used for their expressive power as a feature of masked performance - both ritually and in various theatre traditions. The ritual and theatrical definitions of mask usage frequently overlap and merge but still provide a useful basis for categorization. The image of juxtaposed Comedy and Tragedy masks are widely used to represent the Performing Arts, and specifically Drama. **On the contrary**, Plaintiff's life and liberty is not a comedy, nor shall this Court of Law become a Tragedy. Plaintiff's lawsuit is about reason vs. religion, liberty and law, with Plaintiff having a right to exist as 'I Am' versus a **personal stake** as *defined, designed, driven, devalued, degraded, deprived*, or fearful to be *destroyed* by law respecting an establishment of religion in a matrix of religious dealings. Plaintiff states, FOR THE RECORD, by all the power from Heaven and on Earth, this Nation's System of Justice SHALL NOT BECOME, **just-a-system** for the Performing Arts or for **any** Court of Law. FOR THE RECORD, Plaintiff's **unalienable rights** to life, liberty and pursuit of happiness is not a Theater, nor shall Plaintiff's very genuine and [sincerely held religious beliefs] ("[believes]") become or be used as someone's drama. FOR THE RECORD, The U.S. Constitution & this Nation's Rule of Law, is not playwriting or a written script, nor shall the very instruments of justice be reduced to the scriptures for law respecting an establishment of religion. **IF**... the Defendants fail to obey these commands, your Theater shall be seen in a WAR OR WORDS, **which shall decimate** the manifested injustices in this case and the E.V.I.L. against me, with the Drama, precisely design to defeat the IRS and [A Complacent Policy of Indifference to Evil] *per se* as ("[To LIVE as EVIL]"). FOR THE RECORD, *my judgements* are righteous before the eyes of GOD with my *God-given* powers shall be witnessed in the eyes of the "UNITED STATES" GOVERNMENT. Let NO human authority say otherwise, unless you want to "see" my Face, which has a covenant with God and Country.
