## 0 Instructions for Schedule C Profit or Loss m Business

Use Schedule C (Form 1040) to report income or loss from a business or profession you practiced as a sole proprietor. An activity is a business if you are engaged in the activity for income or profit, and the activity with continuity and regularity. For example, a person who is engaged in the activity of a business, but who does not qualify as a business, is not required to report income from the activity on Form 1040, line 21, or Form 1040NR, line 21.

Also, use Schedule C to report (a) the net profit or loss from a business or profession you practiced as a sole proprietor, or (b) the net profit or loss from a business or profession you practiced as a sole proprietor, or (c) the net profit or loss from a business or profession you practiced as a sole proprietor.
